# ARTIST RELEASE, WAIVER OF LIABILITY & LOAN AGREEMENT

I, the undersigned teacher, on behalf of the students in my class participating in the "2024 Youth Art Show," hereby acknowledge and agree to the terms and conditions set forth in this agreement with the JN Long Cultural Arts Center (JNL CAC) located at 425 Granbury St., Cleburne, TX 76033. The purpose of this agreement is to allow the display of student artwork in the gallery from February 28th, 2023, through March 25th, 2023.

As the authorized representative, I understand and accept the following conditions:

1. The artwork submitted by the students will remain on display for the entire exhibition period unless written permission to remove the work earlier is obtained from the curator.

2. The students and their legal guardians represent themselves as the sole legal owners of all rights, titles, and interests in all artwork submitted. JNL CAC does not carry insurance for loss or damage to artwork in the exhibit, nor does it assume liability for the same.

3. The students grant permission for JNL CAC to reproduce their names, information describing their work, representations of their work, and any other information provided for the purpose of display, promotion, and publicity, both now and in the future.

4. The students and their legal guardians agree to display, pack, transport, and provide for the return of their artwork at their own risk and expense.

5. The students and their legal guardians agree that their artwork shall be removed from the JNL CAC premises by April 6th, 2023; otherwise, it will be considered a donation.

6. The students and their legal guardians agree to allow JNL CAC to promote, photograph, and video artworks in print, web, and/or television.

7. It is understood that JNL CAC will retain a 20% commission on all sales. Purchased artwork must remain on display for the duration of the show and can be picked up after March 25th, 2023.

**WAIVER OF LIABILITY ACKNOWLEDGED:** I understand and agree to the conditions as stated above, and I release the JNL CAC and its owner from liability for loss or damage to the work(s) lent by the students. I, as the teacher, assume any responsibility or obligation for any loss or damaged item(s). This waiver will be kept on file for up to one year following the exhibit.
